## World Economic Forum

GRF CEO Mark Orsi served as a contributor to the WEF white paper <u>Cyber Resilience</u> <u>Index: Advancing Organizational Cyber</u> <u>Resilience</u> which provides public and private sector leaders with a common framework for sound organizational cyber resilience. Mark offered insight into collaboration on threat information sharing and threat mitigation. He proposed that organizations work with industry peers and policy makers, establish sharing agreements with ecosystem partners, and stressed the need for agreed upon processes and expectations on what can and cannot be shared by partners.

## **Atlantic Council**

Orsi also joined the Atlantic Council for a <u>discussion on energy security</u>. He covered threats faced by the sector due to increased connectivity and complexity, but also opportunities to enhance security that should be coupled with energy transition. Mark discussed efforts by the Business Resilience Council to develop third-party and supply-chain resilience, and to build an Operational Resilience Framework supporting recovery of critical services in the face of attacks.

## K12 SIX

Regional Director Eric Lankford recently presented *Cyber Resilience 101: A Non-Technical Guide for Districts of Any Size* to the Colorado Association of School Executives. The session helped district leaders outside of IT gain a better understanding of the current risk landscape and offered some simple precautionary steps, regardless of school size or sophistication, for better preparation against a cyber incident. **The Cyber Resilience Index:** Advancing Organizational Cyber Resilience

Moderated by Jane Lo of MySecurityMedia, the panelists gave insight into their extensive experience in Operational Technology (OT) and shared their personal stories. ### BRC

The Business Resilience Council has extended its offerings beyond alerts and reports on systemic physical and cyber risks. It now tracks significant vulnerabilities and breaches, and provides the means to connect with product and security teams of vendors that support essential business services. When a threat is imminent, or an incident occurs, these vendor connections become vital to BRC members' cybersecurity and continuity teams, for situational awareness and rapid response. The BRC also works with breached vendors to facilitate dialogue with the community, for mutual benefit.

The BRC just held the webinar <u>Grid</u> <u>Resilience vs. Climate Change</u> with Andy Bochman, Senior Grid Strategist for National & Homeland Security at Idaho National Labs. Andy spoke on climate change, the threats it brings and the likely impact to the grid and businesses. The meeting also featured a geopolitical and cybersecurity update.
